## 1. Introduction

Our website, <a href="https://www.landsendhotel.co.uk">https://www.landsendhotel.co.uk</a> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). ## 2. What are cookies?

#### 5.1 Technical or functional cookies
